

**SUPPLY AND DELIVERY OF BRAND-NEW UNITS OF PASSENGER VANS FOR THE
PHILIPPINE COMPETITION**

CONTRACT AGREEMENT

THIS AGREEMENT made on **29 December 2022** between the **Philippine Competition Commission (PCC)** with office address at 25/F Vertis North Corporate Center Tower 1, North Avenue, Quezon City, represented herein by its Executive Director, Kenneth V. Tanate, PhD (hereinafter called "the Entity") and **Marquay Trading OPC.**, with office address at Sitio Mabangos, Garden Coast Subd. Brgy. Capipisa, Cavite, represented herein by its President, Alexis John Razon (hereinafter called "the Supplier");

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Supply and Delivery of Brand-New Units of Passenger Vans for the Philippine Competition Commission** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Two Million Nine Hundred Ninety-Seven Thousand Seven Hundred Forty-Eight Pesos (Php2,997,748.00)**, (hereinafter called "the Contract Price").


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins.
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration of the Contract Price or such other sums as may be ascertained, the Supplier hereby agrees to supply the goods, provide the ancillary services and to remedy the defects therein in accordance with the provisions of this Agreement and its Bid.
4. The Entity agrees to pay the Supplier, in accordance of the provision required goods and ancillary services, the Contract Price or such other sum as may become

payable under the provisions of this Agreement in the time and manner prescribed, and in accordance with the terms of the bid.



Delivery of an executed counterpart of a signature page to this Agreement shall be effective as delivery of a manually executed counterpart of this Agreement.



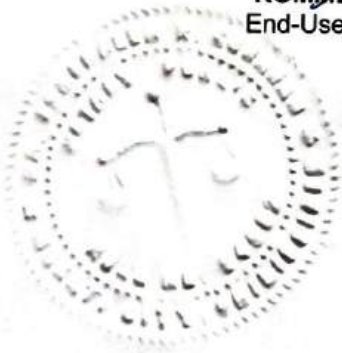

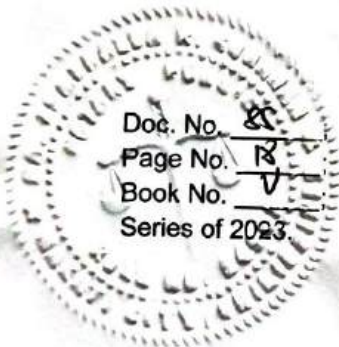
