### CONTRACT AGREEMENT

THIS AGREEMENT is made on the 1st day of January 2025 (the "Agreement") between the Philippine Competition Commission ("PCC"), with office address at 25/F Vertis North Corporate Center Tower 1, North Avenue, Quezon City, represented herein by its Executive Director, Kenneth V. Tanate, PhD (hereinafter referred to as the "Entity") and Copieronline Philippines, Inc., with business address at No. 165 Kamias Road, Brgy. Sikatuna Village, Quezon City, represented herein by its Operations Manager, Mr. Aries A. Matias (hereinafter referred to as the "Service Provider") (collectively herein referred to as "Parties");

The Service Provider agrees that additional contract documents or information prescribed by the Government Policy Procurement Board that may subsequently be required for submission after the contract execution, such as the Notice to Proceed, Amendment Orders, and Warranty Security, shall likewise form part of the Agreement.

3. In consideration of the Contract Price or such other sums as may be ascertained, the Service Provider hereby agrees to execute and complete the said Services and remedy the defects therein in conformity with the provisions of this Agreement in accordance with its bid.


