### CONTRACT AGREEMENT

THIS AGREEMENT is made on the 1st day of January 2025 (the "Agreement") between the **Philippine Competition Commission**, with office address at 25/F Vertis North Corporate Center Tower 1, North Avenue, Quezon City, represented herein by its Executive Director, **Kenneth V. Tanate. PhD.** (hereinafter referred to as the "Entity"), and **Philippine Global Communications, Inc.**, with office address at Philcom Building, 8755 Paseo De Roxas, Makati City, represented herein by its Authorized Representative, **Kristine D. Gamboa** (hereinafter referred to as the "Supplier") (collectively herein referred to as the "Parties");
