#### INVITATION TO BID

### **Procurement of Brand New Motor Vehicles for the Philippine Competition Commission**

1. The Philippine Competition Commission (PCC) intends to apply the sum of Ten Million Four Hundred Thousand Pesos (PhP10,400,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the procurement of eleven (11) units of brand new motor vehicles with the following minimum specifications:

### A. Lot One (1), Five (5) units of motor vehicle with ABC of PhP5,000,000.00

**Award of Contract shall be made on a Per Lot basis.** Bids received in excess of the ABC shall be automatically rejected at bid opening.

- 2. The **PCC**, now invites bids for the procurement of above-stated motor vehicles. Bidders should have completed a contract similar to this project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instructions to Bidders.
- 3. Delivery to PCC office in San Miguel Avenue, Ortigas Center, Pasig City shall be completed within twenty-five (25) calendar days from receipt of the Notice to Proceed. Failure to complete the said delivery within the period stipulated would require the winning bidder to pay corresponding penalties/liquidated damages in accordance with Section VIII of the Bidding Documents.
- 4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

5. Interested bidders may obtain further information from the PCC and inspect the Bidding Documents at the address given below during Office Hours from 9:00 A.M. to 5:00 P.M. (Monday through Friday).

A complete set of Bidding Documents may be acquired by interested Bidders on 18 May 2017 from the address below.

The Bidding Documents may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the PCC. However, Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids, in the following amount (pursuant to GPPB Guidelines and internal guidelines of PCC Bids and Awards Committee (PBAC):

- 6. The PCC will hold a Pre-Bid Conference on 22 May 2017 at 1:30 P.M. at the Board Room, Philippine Competition Commission, 2<sup>nd</sup> Floor, Development Academy of the Philippines (DAP) Bldg., San Miguel Avenue, Ortigas Center, Pasig City, which shall be open to prospective bidders.
- 7. Bids must be duly received by the PCC BAC (PBAC) Secretariat at the address below on or before 12:00 Noon of 05 June 2017. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18 of the Bidding Documents.

Bid opening shall be at 1:30 P.M. on 05 June 2017 at the Board Room, Philippine Competition Commission, 2<sup>nd</sup> Floor, DAP Building, San Miguel Avenue, Ortigas Center, Pasig City. Late bids shall not be accepted.

- 8. The PCC reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
