

## INVITATION TO BID FOR

### *Procurement of ICT Consolidated Software Subscription for the Philippine Competition Commission for C.Y. 2020*

1. The *Philippine Competition Commission (PCC)*, through the *F.Y. 2020 Budget pursuant to Section 19 of the General Provision of the National Expenditure Program and Section 7.6 of the Revised 2016 IRR of the RA No. 9184*, intends to apply the sum of **Two Million Three Hundred Ninety Three Thousand Six Hundred Thirty Seven Pesos (PhP2,393,637.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for *Procurement of ICT Consolidated Software Subscription for the Philippine Competition Commission for C.Y. 2020* under *Invitation to Bid (IB) No. 2020-00-0004*. Bids received in excess of the ABC shall be automatically rejected at bid opening. Award of the contract is on a per lot basis.
2. The *PCC* now invites bids for the following ICT Software Subscription:

- The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.



4. Interested bidders may obtain further information from *PCC* and inspect the Bidding Documents at the address given below during *Office Hours from 9:00 A.M. to 5:00 P.M. (Monday through Friday)*.
5. A complete set of Bidding Documents may be acquired by interested Bidders on *21 November 2019* from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB and internal issuance of PCC Bids and Awards Committee (PBAC), in the amount of *Three Thousand Pesos (PhP3,000.00)*.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The *PCC* will hold a Pre-Bid Conference on *29 November 2019, 02:00 PM* at the address below, which shall be open to all prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before *11 December 2019, 12:00 NN*. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on *11 December 2019, 03:00 PM* at the address below. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The *PCC* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
