PBAC Resolution No. 201910-0143

RECOMMENDING THE AWARD OF CONTRACT TO NOVOTEL MANILA ARANETA CENTER (ARANETA HOTELS INC.) THROUGH NEGOTIATED PROCUREMENT – LEASE OF VENUE FOR THE PROVISION OF VENUE INCLUDING FOOD FOR THE CONDUCT OF COMPETITION POLICY AND LAW FOR MSMEs

WHEREAS, the Philippine Competition Commission (PCC) has allotted in its *Annual Procurement Plan (APP) CY 2019* an Approved Budget for the Contract (ABC) of One Hundred Seventy Six Thousand Pesos (PhP176,000.00) for the “*Provision of Venue including Food for the conduct of Competition Policy and Law for MSMEs on 23 October 2019*”;

WHEREAS, Section 53.10 of the revised Implementing Rules and Regulations (IRR) of RA No. 9184 allows Negotiated Procurement – Lease of Real Property and Venue “for official use subject to Annex “H” of this IRR;

WHEREAS, on 08 October 2019, the Requests for Quotation (RFQs) for the said procurement were conveyed to prospective venue providers, namely: (1) Novotel Manila Araneta Center (Novotel Hotels Inc.); (2) Luxent Hotel, (3) Seda Vertis, (4) Crown Plaza Manila Galleria, and (5) Park Inn North EDSA by Radisson;

WHEREAS, of the prospective bidders invited, the following submitted their quotations:


WHEREAS, based on the evaluation and recommendation of the TWG (Table C – Table of Rating Factors for Lease of Venue of Annex H, Appendix B [C] of the 2016 Revised IRR of RA No. 9184 with End-user’s Hurdle Rate of 90%), the PBAC finds the quotation of Novotel Manila Araneta Center (Novotel Hotels Inc.) as the lowest calculated and responsive quotation in the total amount of One Sixty Five Thousand Pesos (PhP165,000.00);

WHEREAS, Section 12 of RA 9184 mandates the BAC to recommend the award of contract to the Head of Procuring Entity (HOPE) or his/her duly authorized representative.

NOW THEREFORE, the PBAC has **RESOLVED**, as it hereby **RESOLVES** to:


1. Recommend the award of contract through Job Order (JO) to **Novotel Manila Araneta Center (Novotel Hotels Inc.)** for the *Provision of Venue including Food for the conduct of Competition Policy and Law for MSMEs on 23 October 2019* in the amount of *One Hundred Sixty Five Thousand Pesos (PhP165,000.00)*, inclusive of all applicable taxes;
2. Recommend to the HOPE the signing of Notice of Award (NOA) and JO to implement the said contract.


