PBAC Resolution No. 201910-0157

RECOMMENDING THE AWARD OF CONTRACT TO THE CARMEN HOTEL THROUGH NEGOTIATED PROCUREMENT – LEASE OF VENUE FOR THE PROVISION OF VENUE INCLUDING FOOD, ACCOMMODATION, AND INLAND TRANSFERS FOR THE CONDUCT OF SYMPOSIUM ON MERGER REVIEW IN NAGA CITY, CAMARINES SUR

WHEREAS, the Philippine Competition Commission (PCC) has allotted in its *Annual Procurement Plan (APP) CY 2019* an Approved Budget for the Contract (ABC) of Two Hundred Eighteen Thousand Pesos (PhP218,000.00) for the “*Provision of Venue including Food, Accommodation, and Inland Transfers for the Conduct of Symposium on Merger Review in Naga City, Camarines Sur*”;

WHEREAS, Section 53.10 of the revised Implementing Rules and Regulations (IRR) of RA No. 9184 allows Negotiated Procurement – Lease of Real Property and Venue “for official use subject to Annex “H” of this IRR;

WHEREAS, on 08 October 2019, the Requests for Quotation (RFQs) for the said procurement were conveyed to prospective venue providers, namely: (1) The Carmen Hotel, (2) Primus Hotel and Resort, and (3) The Avenue Plaza Hotel;

WHEREAS, of the prospective bidders invited, the following submitted their quotations:


WHEREAS, based on the evaluation and recommendation of the TWG (Table C – Table of Rating Factors for Lease of Venue of Annex H, Appendix B [C] of the 2016 Revised IRR of RA No. 9184 with End-user’s Hurdle Rate of 85%), the PBAC finds the quotation of The Carmen Hotel as the lowest calculated and responsive quotation in the total amount of Two Hundred Seven Thousand Four Hundred Pesos and 4/100 (PhP207,400.04);

WHEREAS, Section 12 of RA 9184 mandates the BAC to recommend the award of contract to the Head of Procuring Entity (HOPE) or his/her duly authorized representative.

NOW THEREFORE, the PBAC has **RESOLVED**, as it hereby **RESOLVES** to:

1. Recommend the award of contract through Job Order (JO) to **The Carmen Hotel** for the *Provision of Venue including Food, Accommodation, and Inland Transfers for the Conduct of Symposium on Merger Review in Naga City, Camarines Sur* in the amount of *Two Hundred Seven Thousand Four Hundred Pesos and 4/100 (PhP207,400.04)*, inclusive of all applicable taxes;
2. Recommend to the HOPE the signing of Notice of Award (NOA) and JO to implement the said contract.


