### PBAC Resolution No. 201909- 0125

#### RECOMMENDING THE AWARD OF CONTRACT THROUGH NEGOTIATED PROCUREMENT – AGENCY-TO-AGENCY TO DEVELOPMENT ACADEMY OF THE PHILIPPINES CONFERENCE CENTER FOR THE PROVISION OF VENUE INCLUDING FOOD AND ACCOMMODATION FOR THE CONDUCT OF FPMO OPERATIONAL PLANNING WORKSHOP FOR F.Y. 2020-2021

**WHEREAS**, the Philippine Competition Commission (PCC) has allotted in its *Annual Procurement Plan (APP) CY 2019* with an approved budget for the contract (ABC) of One Hundred Sixty Three Thousand Eight Hundred Pesos (PhP163,800.00) for the “*Provision of Venue including Food and Accommodation for the conduct of FPMO Operational Planning Workshop for F.Y. 2020-2021 on 22-24 September 2019*”;

**WHEREAS**, Annex “H” of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184 allows procuring entities to use Negotiated Procurement – Agency-to-Agency as an alternative mode of procurement when “procurement from another agency of the procurement (i.e. Service Agency) that has the mandate to deliver goods or services or to undertake infrastructure projects or consultancy services as required by the Procuring Entity”;

**WHEREAS**, in the certification submitted by Development Academy of the Philippines (DAP) Conference Center dated 17 September 2019, DAP has the mandate to deliver the services required for the holding of the subject procurement and it owns the function room, guest rooms, food and beverages services and other facilities required for the event. Furthermore, the DAP certifies its compliance with all the required general conditions as provided for in RA 9184 – Government Reform Act and its Implementing Guidelines on Agency-to-Agency agreement;

**WHEREAS**, DAP Conference Center has tendered a price quotation for the following subscription period:

Recommend the award of contract through Negotiated Procurement – Agency-to-Agency to *Development Academy of the Philippines Conference Center* for the procurement of *Provision of Venue including Food and Accommodation for the conduct of FPMO Operational Planning Workshop for F.Y. 2020-2021* in the total contract amount of *One Hundred Forty Eight Thousand Seven Hundred Sixty Five Pesos (PhP148,765.00)*, inclusive of all applicable taxes;
2. Recommend to the Head of Procuring Entity the approval of the Notice of Award and Job Order.




