

CONTRACT AGREEMENT

THIS AGREEMENT is made on the 12th day of May 2023 (the "Agreement") between the **Philippine Competition Commission**, with office address at 25/F Vertis North Corporate Center Tower 1, North Avenue, Quezon City, represented herein by its Executive Director, Kenneth V. Tanate, PhD (hereinafter referred to as the "Entity"), and **Ms. Irma S. Besas**, with office address at 26 Mira Verde Avenue, Mira Verde Subdivision Nangka, Marikina City (hereinafter referred to as the "Consultant") (collectively herein referred to as the "Parties");

WHEREAS, the Entity is desirous in engaging the services of a Highly Technical Consultant, particularly for the **Engagement of a Highly Technical Consultant for Assessment and Improvement of the Financial Policies and Regulations of the Philippine Competition Commission** (the "Consulting Services") and has accepted a bid by the Consultant for the execution and completion of the Consulting Services in the sum of **Three Hundred Thousand Pesos (PhP300,000.00)**, inclusive of all applicable charges and taxes (the "Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Request for Quotation;
 - ii. Schedule of Requirements;
 - iii. Terms of Reference;
 - iv. Notice of Award of Contract and the Consultant's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the Philippine Bidding Documents.

The Consultant agrees that additional contract documents or information prescribed by the Government Policy Procurement Board that may be required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Agreement.

3. In consideration of the Contract Price or such other sums as may be ascertained, the Consultant agrees to provide the consultancy services and to remedy the defects therein in conformity with the provisions of this Agreement in accordance with his bid.
4. The Entity agrees to pay the Consultant, in consideration of the provision of the required consultancy services, the Contract Price or such other sum as may become payable under the provisions of this Agreement in the time and manner prescribed, and in accordance with the terms of the bid.
5. This Agreement may be executed in one or more counterparts, each of which when executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page to this Agreement shall be effective as deliver of a manually executed counterpart of this Agreement.


