CONTRACT AGREEMENT

THIS AGREEMENT is made on the 1st day of January 2023 between the **Philippine Competition Commission**, with office address at 25/F Vertis North Corporate Center Tower 1, North Avenue, Quezon City, represented herein by its Executive Director, Kenneth V. Tanate, PhD (hereinafter referred to as the "Entity"), and **Circa Security and Investigation, Inc.**, with office address at 30-A Goldstar Bldg., Malhacan Road Malhacan, Meycauayan, Bulacan, represented herein by its Operations Officer, Rommel Jay L. Lagadan, (hereinafter referred to as the "Parties");

WHEREAS, the Entity invited bids for the provision of certain ancillary services, particularly the *Provision of Security Services for the Philippine Competition Commission for CY 2023*, and has accepted the bid by the Service Provider for the supply of such services, in the sum of *One Million One Hundred Twenty-Eight Thousand Five Hundred Eighty-Five and 48/100 Pesos (PhP1,128,585.48)*, inclusive of all applicable charges and taxes ("Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- The following documents as required under the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral parts of this Agreement, viz.:
 - Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - The Service Provider's bid, including the eligibility requirements, technical and financial proposals, and all other documents or statements submitted;
 - iii. Bid form, including all the documents/statements contained in the Service Provider's bidding envelopes as annexes, and all other documents submitted, including but not limited to the Supplier's response to requests for clarifications on the bid, and corrections to the bid, if any, resulting from the Entity's bid evaluation;
 - iv. Performance Security:
 - Notice of Award of Contract; and the Service Provider's conforme thereto;
 and
 - vi. Other contract documents that may be required by existing laws and/or the Entity concerned in the PBDs.

The Service Provider agrees that additional contract documents or information prescribed by the Government Procurement Policy Board that may be required for submission after the contract execution, such as but not limited to the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Agreement.

 In consideration of the Contract Price or such other sums as may be ascertained, the Service Provider agrees to provide the services and to remedy any defects therein in accordance with this Agreement and its bid.

- 4. The Entity agrees to pay the Service Provider, in consideration of the provision of the required services, the Contract Price or such other sum as may become payable under the provisions of this Agreement in the time and manner prescribed, and in accordance with the terms of the bid.
- 5. This Agreement may be executed in one or more counterparts, each of which when executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page to this Agreement shall be effective as deliver of a manually executed counterpart of this Agreement.
