

CONTRACT AGREEMENT

SUPPLY, DELIVERY, INSTALLATION AND TESTING OF HYPERCONVERGED SERVER FOR THE PHILIPPINE COMPETITION COMMISSION DATA CENTER INFRASTRUCTURE

MAY 3 1 2022

THIS AGREEMENT made on the ___ day of May 2022 between the *Philippine Competition Commission (PCC)*, with office address at 25/F Tower I, Vertis North Corporate Center, North Avenue, Quezon City 1105 (hereinafter called "*the Entity*") and *Infocentric Solutions, Inc.*, represented by its Account Manager, Marjorie A. Ona with business address at 200 Canley Road Brgy. Bagong Ilog Pasig City, hereinafter called "*the Supplier*") (collectively herein referred to as "*Parties*"):

WHEREAS, the Entity requested for quotation for certain services for the *Supply, Delivery, Installation and Testing of Hyperconverged Server for the Philippine Competition Commission Data Center Infrastructure* and has accepted a Bid by the Supplier, declared as the Lowest Calculated and Responsive Bidder, for the services in the sum of *Eight Million Eight Hundred Ninety-Eight Thousand Five Hundred Pesos (PhP8,898,500.00)* inclusive of all applicable taxes (hereinafter called "*the Contract Price*").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - a. The Conformed Terms of Reference;
 - b. The Supplier's bid, including the Technical and Financial Proposals;
 - c. The Bid forms, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents/statements submitted, including corrections to the bid, if any, resulting from the Entity's bid evaluation;
 - d. The Eligibility requirements, documents and/or statements;
 - e. Performance Security;
 - f. Notice of Award of Contract and the Bidder's conforme thereto; Conditions of Contract; and
 - g. Other contract documents that may be required by existing laws and/or the Entity.

The Supplier agrees that additional contract documents or information prescribed by the Government Procurement Policy Board that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration of the Contract Price or such other sums as may be ascertained, the Supplier hereby agrees to provide the Entity the goods and services required under the Contract, and to remedy any defects therein, in conformity with the provisions of the Contract and in accordance with its Bid.


4. The Entity hereby agrees to pay the Supplier, in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price at the time and in the manner prescribed by the Contract and the terms of the Bidding.
5. This Agreement may be executed in one or more counterparts, each of which when executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page to this Agreement shall be effective as deliver of a manually executed counterpart of this Agreement.
