



CONTRACT AGREEMENT

**SUPPLY, DELIVERY, AND INSTALLATION OF OFFICE FURNITURE AND
FIXTURES FOR THE LEASED OFFICE SPACE OF PCC:
Lot 3: SUPPLY AND DELIVERY OF MOBILE PEDESTAL AND HEAVY-DUTY
STEEL RACKS**

THIS AGREEMENT made on the ___ day of October 2023 between the *Philippine Competition Commission (PCC)*, with office address at 25/F Tower I, Vertis North Corporate Center, North Avenue, Quezon City (hereinafter called "*the Entity*") and *Mobler Contract Group, Inc.* represented by its Vice President-Operation, Mr. Kenneth Elvin C. Sy with business address at 167 F. Manalo Street, Brgy. Kabayanan, San Juan City (hereinafter called "*the Supplier*") (collectively herein referred to as "*Parties*");

WHEREAS, the Entity requested for a quotation for certain services for the *Supply, Delivery, and Installation of Office Furniture and Fixtures for the Leased Office Space of PCC* and has accepted a Bid by the Supplier for *Lot 3: Supply and Delivery of Mobile Pedestal and Heavy-Duty Steel Racks* in the sum of *Three Hundred Eighty-Two Thousand Eight Hundred Pesos Only (PhP382,800.00)* inclusive of all applicable taxes (hereinafter called "*the Contract Price*").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.


