

NOTICE TO THE PUBLIC

The Office of the Executive Director (OED) of the Philippine Competition Commission (PCC) has received reports that there are unscrupulous individuals using the name of the PCC and Executive Director Kenneth V. Tanate asking for donations and monetary entitlements for certain projects, events, or programs to extort money or gain favors.


The PCC wishes to clarify that solicitation involving public official and employees is prohibited by law and a corresponding action will be imposed for those who will be found committing such violation.

The public is thus advised, particularly the suppliers, service providers, and other stakeholders of the PCC, that such acts are neither authorized nor tolerated by the Executive Director or by the PCC. If you receive a call, we urge you not to befall in such illegal activities and the same should be reported immediately to the OED through telephone number 8771-9722 or email at oed@phcc.gov.ph.
