Supply and Delivery of Brand – New Laptop Computer

CONTRACT AGREEMENT

THIS AGREEMENT made on the JUN 07 2024 day of June 2024 (the "Agreement") between the *Philippine Competition Commission*, with office address at 25/F Vertis North Corporate Center Tower 1, North Avenue, Quezon City, represented herein by its Executive Director, **Kenneth V. Tanate, PhD** (hereinafter referred to as the "Entity"), and *Columbia Technologies, Inc.*, with office address at 1136-1146 J. Nakpil St. Malate, Metro Manila, represented herein by its Account Manager, **Mary Grace D. Gregorio** (hereinafter referred to as the "Supplier").

WHEREAS, the Entity invited Bids for certain goods, particularly for the *Procurement of Brand-New Laptop Computer* (the "Goods") and has accepted a Bid by the Supplier for the delivery of the said goods in the sum of **Three Million Nine Hundred Five Thousand Five Hundred Pesos Only (PhP3,905,500.00)** inclusive of all applicable charges and taxes (hereinafter referred to as the "Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:
 - i. Bid Proposal;
 - ii. Schedule of Requirements;
 - iii. Technical Specifications;
 - iv. Notice of Award of Contract and the Supplier's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the Philippine Bidding Documents.

The Supplier agrees that additional contract documents or information prescribed by the Government Policy Procurement Board that may subsequently be required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Agreement.


3. In consideration of the Contract Price or such other sums, as may be ascertained, the Supplier agrees to provide the delivery of the said goods and to remedy the defects therein in conformity with the provisions of this Agreement in accordance with its Bid.
4. The Entity agrees to pay the Supplier, in consideration of the provision of the required goods, the Contract Price or such other sum as may become payable under the provisions of this Agreement in the time and manner prescribed, and in accordance with the terms of the Bid.
5. This Agreement may be executed in one or more counterparts, each of which when executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page to this Agreement shall be effective as delivery of a manually executed counterpart of this Agreement.


