

Procurement of Service Provider for Individual and Household Focus Group Discussions for the Analysis of PCC Cases and Other Research Initiatives

CONTRACT AGREEMENT

THIS AGREEMENT is made on the ___ day of September 2024 (the "Agreement") between the **Philippine Competition Commission** ("PCC"), with office address at 25/F Vertis North Corporate Center Tower 1, North Avenue, Quezon City, represented herein by its Executive Director, **Kenneth V. Tanate, PhD** (hereinafter referred to as the "Entity") and **The Philippine Survey and Research Center, Inc.**, with business address at 10/F OMM-Citra Bldg. San Miguel Ave. Ortigas Center, Pasig City, represented herein by its Executive Director, **Ms. Maria Cristina C. Reyes** (hereinafter referred to as the "Service Provider") (collectively herein referred to as "Parties");

WHEREAS, the Entity requested for consultancy services, particularly for the **Procurement of Service Provider for Individual and Household Focus Group Discussions for the Analysis of PCC Cases and Other Research Initiatives** (the "Consulting Services") and has accepted a bid by the Service Provider for the execution and completion of the Consulting Services for a period of six (6) months, or until 31 March 2025, in the sum of **Nine Hundred Fifty Thousand Pesos (PhP950,000.00)** inclusive of all applicable taxes (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Request for Expression of Interest;
 - ii. Schedule of Requirements;
 - iii. Terms of Reference;
 - iv. Notice of Award of Contract and the Consultant's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the Philippine Bidding Documents.

The Consultant agrees that additional contract documents or information prescribed by the Government Policy Procurement Board that maybe required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Agreement.

3. In consideration of the Contract Price or such other sums as may be ascertained, the Service Provider hereby agrees with the Entity to




execute and complete the Consulting Services and remedy the defects therein in conformity with the provisions of this Agreement in accordance with its bid.


- 4. The Entity agrees to pay the Service Provider, in consideration of the provision of the required Consulting Services, the Contract Price or such other sum as may become payable under the provisions of this Agreement in the time and manner prescribed, and in accordance with the terms of the bid.
- 5. This Agreement may be executed in one or more counterparts, each of which when executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page to this Agreement shall be effective as delivery of a manually executed counterpart of this Agreement.


