

Provision of Security Services for the Philippine Competition Commission for CY 2024

CONTRACT AGREEMENT

THIS AGREEMENT is made on the 07 day of January 2024 (the "Agreement") between the **Philippine Competition Commission**, with office address at 25/F Vertis North Corporate Center Tower 1, North Avenue, Quezon City, represented herein by its Executive Director, **Kenneth V. Tanate, PhD.** (hereinafter referred to as the "Entity"), and **Circa Security and Investigation, Inc.**, with office address at 30A Goldstar Building, Malhacan Road, Meycauayan City, Bulacan, represented herein by its President and General Manager, **Rita R. Gonzales** (hereinafter referred to as the "Supplier") (collectively herein referred to as the "Parties");

WHEREAS, the Entity is desirous in procuring goods from the Supplier, particularly for the **Provision of Security Services for the Philippine Competition Commission for CY 2024** (the "Goods") and has accepted a bid by the provider of the said services in the sum of **Two Million Three Hundred Seventy Thousand One Hundred Twenty-Four Pesos and Eighty Centavos (PhP2,370,124.80)**, inclusive of all applicable charges and taxes (the "Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Request for Quotation;
 - ii. Schedule of Requirements;
 - iii. Technical Specifications;
 - iv. Notice of Award of Contract and the Supplier's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the Philippine Bidding Documents.

The Supplier agrees that additional contract documents or information prescribed by the Government Policy Procurement Board that may be required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Agreement.


3. In consideration of the Contract Price or such other sums as may be ascertained, the Supplier agrees to provide the delivery of the said services and to remedy the defects therein in conformity with the provisions of this Agreement in accordance with its bid.
4. The Entity agrees to pay the Supplier, in consideration of the provision of the required goods, the Contract Price or such other sum as may become payable under the provisions of this Agreement in the time and manner prescribed, and in accordance with the terms of the bid.
5. This Agreement may be executed in one or more counterparts, each of which when executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page to this Agreement shall be effective as delivery of a manually executed counterpart of this Agreement.






