

# CONTRACT AGREEMENT

## CONTRACT AGREEMENT FOR THE PROCUREMENT OF SUBSCRIPTION SERVICES OF MOBILE COMMUNICATION DEVICES FOR THE PHILIPPINE COMPETITION COMMISSION

THIS AGREEMENT is made and entered into on the 13 day of January 2022 by and between: the *Philippine Competition Commission ("PCC")* represented herein by its Executive Director and Head of Procuring Entity Kenneth V. Tanate, PhD., with office address at 25/F Vertis North Corporate Center Tower 1, North Avenue, Quezon City (hereinafter referred to as "the Entity") and *Globe Telecom, Inc.* represented herein by its Senior Vice President - Enterprise Group Head, Mr. Pedro Canisio D. Maquera, with office address The Globe Tower, 32nd Street Corner 7th Avenue, Bonifacio Global City, Taguig City, Metro Manila (hereinafter referred to as "the Service Provider" or "the Bidder") (collectively herein referred to as "the Parties").

WHEREAS, the Entity requested the submission of bids for the *Procurement of Subscription Services of Mobile Communication Devices for the Philippine Competition Commission* and has accepted a Bid by the Service Provider, declared as the Lowest Responsive Bidder, in the sum of *Three Hundred Sixty-Three Thousand Eight Hundred Eighty-Eight Pesos (PhP363,888.00)*, inclusive of all applicable taxes (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:
  - a. The Conformed Terms of Reference;
  - b. The Service Provider's bid, including the Technical and Financial Proposals;
  - c. PhilGEPS Registration;
  - d. Mayor's Permit or equivalent document;
  - e. Income Tax Return or equivalent document;
  - f. Notarized Certificate of Proprietorship/Distributorship;
  - g. Performance Security;
  - h. Notice of Award of Contract and the Bidder's conforme thereto; Conditions of Contract; and
  - i. Other contract documents that may be required by existing laws and/or the Entity.

The Service Provider agrees that additional contract documents or information prescribed by the GPBB that are subsequently required for submission after the contract

execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration of the payments to be made by the Entity to the Service Provider as stated above, the Service Provider hereby agrees to provide to the Entity the said services, complete the same and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby agrees to pay the Service Provider, in consideration of the provision of the services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the time and in the manner prescribed by the Contract.
