CONTRACT AGREEMENT

**SUPPLY, DELIVERY, AND INSTALLATION OF OFFICE FURNITURE AND
FIXTURES FOR THE LEASED OFFICE SPACE OF PCC:
LOT 2: SUPPLY, DELIVERY AND INSTALLATION OF CUSTOMIZED FURNITURE
AND FIXTURES**

THIS AGREEMENT made on the NOV 06 2023 day of November 2023 between the *Philippine Competition Commission (PCC)*, with office address at 25/F Tower I, Vertis North Corporate Center, North Avenue, Quezon City (hereinafter called "*the Entity*") and *Peniton Trading* represented by its Owner/General Manager, Ms. Gemma T. Peniton with business address at Lot 7 Blk 1 Zabarte Road, Brgy. 177, Camarin, Caloocan City (hereinafter called "*the Supplier*") (collectively herein referred to as "*Parties*");

WHEREAS, the Entity requested for a quotation for certain services for the *Supply, Delivery, and Installation of Office Furniture and Fixtures for the Leased Office Space of PCC* and has accepted a Bid by the Supplier for *Lot 2: Supply, Delivery and Installation of Customized Furniture and Fixtures* in the sum of *One Million Ninety-Nine Thousand Pesos Only (PhP1,099,000.00)* inclusive of all applicable taxes (hereinafter called "*the Contract Price*").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;


Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration of the sum of the Contract Price or such other sums as may be ascertained, the Service Provider hereby agrees with the Entity to execute and complete the Consulting Services and remedy any defects therein in conformity with the provisions of this Agreement and its Bid.
4. The Entity agrees to pay the Contract Price in accordance with the terms of the Bidding.


