### PBAC Resolution No. 201912-0179

#### RECOMMENDING THE AWARD OF CONTRACT TO CANYON COVE HOTEL AND SPA, INC. THROUGH NEGOTIATED PROCUREMENT – LEASE OF VENUE FOR THE PROVISION OF VENUE INCLUDING FOOD, AND ACCOMMODATION FOR THE CONDUCT OF MAO YEAR-END ASSESSMENT WORKSHOP AND WRITESHOP, AND EO YEAR-END ASSESSMENT WORKSHOP AND IN-HOUSE HANDS-ON CRASH COURSE

**WHEREAS**, the Philippine Competition Commission (PCC) has allotted in its *Annual Procurement Plan (APP) CY 2019* an Approved Budget for the Contract (ABC) of Three Hundred Thirty Six Thousand Pesos (PhP336,000.00) for the “*Provision of Venue including Food, and Accommodation for the conduct of MAO Year-end Assessment Workshop and Writeshop, and EO Year-end Assessment Workshop and In-house Hands-on Crash Course*”;

**WHEREAS**, Section 53.10 of the revised Implementing Rules and Regulations (IRR) of RA No. 9184 allows Negotiated Procurement – Lease of Real Property and Venue “for official use subject to Annex “H” of this IRR;

**WHEREAS**, on 29 November 2019, the Requests for Quotation (RFQs) for the said procurement were conveyed to prospective venue providers, namely: (1) Canyon Cove Hotel and Spa, Inc., (2) Pico Sands Hotel, (3) Acuatico Beach Resort, (4) Vivere Azure, (5) Estrella De Mendoza, and (6) Club Punta Fuego;

**WHEREAS**, of the prospective bidders invited, the following submitted their quotations:

**WHEREAS**, based on the evaluation and recommendation of the TWG (Table C – Table of Rating Factors for Lease of Venue of Annex H, Appendix B [C] of the 2016 Revised IRR of RA No. 9184 with End-user’s Hurdle Rate of 90%), the PBAC finds the quotation of Canyon Cove Hotel and Spa, Inc. as the lowest calculated and responsive quotation in the total amount of Three Hundred Thirty Six Thousand Pesos (PhP336,000.00);

Recommend the award of contract through Job Order (JO) to **Canyon Cove Hotel and Spa, Inc.** for the *Provision of Venue including Food, and Accommodation for the conduct of MAO Year-end Assessment Workshop and Writeshop, and EO Year-end Assessment Workshop and In-house Hands-on Crash Course* in the amount of **Three Hundred Thirty Six Thousand Pesos (PhP336,000.00)**, inclusive of all applicable taxes;
2. Recommend to the HOPE the signing of Notice of Award (NOA) and JO to implement the said contract.


