

CONTRACT AGREEMENT

THIS AGREEMENT made on the 1<sup>st</sup> day of January 2023 between the **Philippine Competition Commission** (PCC) with office address at 25/F Vertis North Corporate Center Tower 1, North Avenue, Quezon City (hereinafter called "the Entity") and **U-Bix Corporation** with office address at 1344 Angono St., Makati City (hereinafter called "the Service Provider");


WHEREAS, the Entity invited Bids for certain goods and ancillary services for the *Procurement of Centralized Print, Copy, and Scan Services Solution for the PCC for C.Y. 2023* and has accepted a Bid by the Service Provider for the supply of those goods and services in the sum of *Six Hundred Eighty-Seven Thousand Nine Hundred Sixty Pesos (PhP687,960.00)*, (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
  - i. Philippine Bidding Documents (PBDs);
    - i. Schedule of Requirements;
    - ii. Technical Specifications;
    - iii. General and Special Conditions of Contract; and
    - iv. Supplemental or Bid Bulletins
  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;  
  
Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - iii. Performance Security;
  - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
  - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs.
3. In consideration of the Contract Price or such other sums as may be ascertained, the Service Provider hereby agrees with the Entity to execute and complete the services and remedy any defects therein in conformity with the provisions of this Agreement and its bid.
4. The Entity agrees to pay the Service Provider, in consideration of the provision of the required services, the Contract Price or such other sum as may become payable under the provisions of this Agreement in the time and manner prescribed, and in accordance with the terms of the bid.
5. This Agreement may be executed in one or more counterparts, each of which when executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page to this Agreement shall be effective as deliver of a manually executed counterpart of this Agreement.
